COVID-19 vaccine rollout dates by DHB

As communicated to the membership on Monday, the NZACA has received a list of planned vaccination rollout start dates by DHB from the office of Hon Dr Ayesha Verrall, Associate Minister of Health.

Influenza vaccine

Ideally, there should be a gap of 2 weeks or more between the influenza and COVID-19 vaccinations. If the influenza vaccines is scheduled for your staff over the age of 65 but you have not yet heard from your DHB regarding COVID-19 vaccinations to staff, please contact your DHB HOP lead to check when your staff are scheduled for their COVID-19 vaccinations.

Adverse events

Medsafe has published its second summary of Adverse Events Following Immunisation (AEFI) with COVID-19 vaccines - <u>Safety Report #3 - 20 March 2021</u> (published 21 April 2021). There were 83 new non-serious and four new serious cases reported since the last update. The four serious reports were allergic reactions and were managed appropriately.
